

**RESPONSES TO INQUIRIES RECEIVED THROUGH
THE ISSUANCE OF ADDENDUM NO. 3**

Q#138 Can I bid on just a part of the scope of work (e.g. the permitting updates vs. the entire project)?

A#138 See responses to Q#21, Q#22, and Q#23 in Addendum No. 1. Further answering, the Commission desires to enter into a single contract for the services necessary to complete the Project. See bold print in PART I on page 3 and PART II - SCOPE OF SERVICES on page 7 of the RFP. Accordingly, each response to the RFP should propose to perform all services described in the RFP

Q#139 Is proof of insurance required with the proposal or upon executing the contract?

A#139 Evidence of insurance is required to be submitted with the Proposal. See Section F of PART VII on page 43 of the RFP. However, a certificate of insurance identifying the Commission as an additional insured is not required until execution of the Contract with the Commission. See Section Q of PART XIV on page 53 of the RFP.

Q#140 How can a firm provide a concrete bid for the permitting update without complete system specifications? Will those specs be made available?

A#140 These specifications will be developed in consultation with the Selected Firm and compensated on an hourly basis.

Q#141 Will technical specifications for the E-ZPass Content Reconfiguration be available prior to project kickoff?

A#141 Should the Commission elect to obtain the services described under the E-ZPass Content Reconfiguration section of the RFP, these specifications will be developed in consultation with the Selected Firm and compensated on an hourly basis.

Q#142 Regarding ADA Compliance, is there a specific level required related to WCAG 2.0? level A, AA or AAA?

A#142 State of Ohio IT Policy No. IIP-F.3, effective Aug 20, 2007, requires state websites to comply with the accessibility standards set forth in Section 1194.22 of Chapter 36 of the Code of Federal Regulations. The CFR at 36-1194 22 prescribes the requirements for achieving Level A of WCAG 1.0. However, compliance with Level A under WCAG 2.0 is desired

Q#143 As a follow-up question to Q#3 in Addendum 1, if an agency does not test its employees for drugs and alcohol post-accident or through a random process, is it disqualified from the chance to be awarded the contract?

A#143 The Responding Firm's drug free workplace policy must fulfill the minimum requirements necessary to obtain the Bureau of Workers Compensation's approval. While the Commission prefers policies that provide for both random and post-accident testing, random testing is not required for approval of basic-level BWC DFWP policies, but post-accident testing is required. The Ohio Bureau of Workers Compensation's publication titled "Drug-Free Safety Program Self-Implementation Workbook" describes the basic components of an acceptable drug free workplace policy and is available here. <http://www.ohiobwc.com/downloads/blankpdf/DFSPSelfImplementationWorkbook.pdf>
